All the students who are applying for Photocopy & Revaluation should apply online for revaluation & Photocopy from the web Site (www.kgce.org or www.kgceexam.org on or before **28.02.2017** after the due date the link will be disabled and no form will be accepted after the due date even with late fee.

Read the instructions carefully while filling the form.

50% fees concession in the fees for SC,ST,DT,NT,EBC students (to get the concession in fees should attach Xerox of caste certificate & caste validity certificate & Income Certificate for EBC student).

Fees to be paid in office (Cash hour 10.30 A.M. to 1.00 P.M. & 2 P.M. – 3.00 P.M.)

Form submission in Exam Section. (10.30 A.M. to 1.00 P.M. & 2.30 P.M. – 3.00 P.M.)

Revaluation Fees : 500/- per subject & Photocopy Fees 100/- per subject

Note:

1. Incomplete application forms will be rejected without assigning any reason and whatsoever the fees paid along with the application form neither be refunded nor any representation be entertained.
2. **If Seat No./Subject or any information is wrongly entered by the student, college will not be responsible and fees will not be refunded or will not consider for Photocopy / Revaluation.**
If the student fail to submit the Revaluation / Photocopy form after paying the fee in the given dates will not be consider for revaluation / Photocopy or any refund of fees under any circumstances.
3. No application after the due date will be entertained on any ground.
4. The Photocopy/Xerox copy/ies so obtained by the candidate shall be for his / her exclusive and relevant use. Neither the said candidate nor any other person can use the said copy to dispute or challenge the quality of assessment or quantum of marks assign to the answers therein.

On receipt of the Photocopy if the discrepancy of the following nature is noticed by the candidate should apply in the prescribe form along with all the details within three(03) working days from the date of collection of the photocopy by the candidate(If the candidates fail to collect the photocopy in due course of time, form will not be accepted for any type of discrepancy.
